On a retirement account such as an IRA, 401k or other plan, you can name AdventHealth Hendersonville Foundation as a beneficiary for all or a portion of your account.

- Request or download a beneficiary designation form for your retirement account.
- Designate AdventHealth Hendersonville Foundation (Federal Tax ID 59-2219301) as sole, partial or contingent beneficiary.
- Sign and return the form to your plan administrator and keep a copy for your files.

Making these plans doesn't change your ability to use these assets during your lifetime, or the provisions you've made for loved ones.
