#### Who?

The Council is comprised of AdventHealth team members and community leaders.

### What?

The Collaborative Community Council is the funding entity for AdventHealth's community grant program in Orange, Osceola and Seminole counties.

#### Why?

AdventHealth seeks to identify and partner with community organizations to create effective, impactful solutions that can improve the health of the communities we serve and reduce preventable medical costs.

#### How?

AdventHealth provides funding to non-profit organizations in Orange, Osceola and Seminole counties, which focus on health needs of the Central Florida community. Funding is allocated to projects that address the needs which have been identified with input from the community during the 2019 Community Health Needs Assessment.

# **Required Grant Criteria**

Grant applicants must be able to answer yes to all of the following questions to be eligible for funding.




# Is your organization a local non-profit and exempt from federal income tax?

Non-profit organizations that are applying must include a letter of exemption from federal income tax under Section 501(c)(3) and their most recent IRS form 990 or 990EZ.

# 2. Does your project address one of the following health needs of the uninsured, underserved or vulnerable populations in Orange, Osceola, Seminole counties as identified through the 2019 Community Health Needs Assessment?

# **Required Grant Criteria Cont.**

- 3.) Are there clearly defined, measurable goals built into your project?
- 4. Does your project include a sustainability plan to maintain the initiative when the grant funding has ceased?





# **Preferred Criteria**

Stronger consideration will be given to projects that include the following criteria.



The project is a collaboration between multiple agencies and offers opportunities for matching funds or in-kind support



The organization applying can demonstrate an ability to sustain and operationalize pilots using examples of past grant funding.



The project has trackable metrics that can be tied to lower healthcare costs



The project employs a place-based approach that addresses social determinants of health



A pipeline is developed to enroll patients or clients to the project




A marketing plan is in place to reach individuals who would benefit from the project if there is not a pipeline

## Grant Application Checklist Collaborative Community Council RFP

Non-profit organizations that would like to apply for the grant can access the RFP here. Applicants will need to provide information for the following when applying.

Contact information
Proposed program name
High-level overview of the program or grant request (300-character limit)
Goal/objective of the program (300-character limit)
Detailed timeline overview of your project, including any build-out that must be completed before the program can start
Area of focus (refer to page 4 for list of priorities)
How does the program address one of AdventHealth's priorities? (400-character limit)
Counties in which the program will be available
Population served by program (200-character limit)
Marketing strategy for program (500-character limit)
Explanation of both exisiting and new pipelines geared towards educating and connecting individuals to the program
How will metrics be used to measure success?
Best practices implemented or models the program is incorporating (Documentation will be required to substantiate answers)



## **Grant Application Checklist Cont.** Collaborative Community Council RFP

Non-profit organizations that would like to apply for the grant can access the RFP here. Applicants will need to provide information for the following when applying.

Total amount requested (per year amount)
Project duration (one, two, or three years)
Resources that will be obtained with grant funding (300-character limit)
Sustainability plan for program after funding has ceased
If applicable, history of other programs (that started with seed or grant funding) that have been operationalized by the organization
Additional partners involved in program/initiative
Percentage and description of staff from organization that will be involved in the program (200-character limit)
If volunteers will be used, outline how they will interact with individuals enrolled in the program and any background checks that will be provided.
