# Bringing a Million Smiles with Disney Magic

The Walt Disney World Pavilion at AdventHealth for Children is an amazing place. Along with a medical team that provides nationally recognized care to our littlest patients, we have partnered with The Walt Disney Company to create a magical experience to bring smiles and laughter to children and their families in our hospital.

The Walt Disney Company is committed to delivering comfort and inspiration to children facing serious illness. This commitment dates back to Walt Disney himself, who would visit with children in hospitals, often accompanied by Disney characters and animators. In 2018, Disney built on this legacy by announcing a five-year, \$100 million commitment to help reimagine the patient journey in children's hospitals. AdventHealth for Children was chosen as one of the first hospitals in Florida and in the nation to showcase this initiative.

The program was unveiled on February 6th with a ribbon cutting of epic proportions. Hallways are completely transformed with stunning murals themed from Disney, Pixar, Star Wars and Marvel

which draw one's imagination into Disney's vibrant worlds. Magic Windows in the waiting rooms provide mesmerizing views into beloved Disney stories. Magic Arts on the patient floors are delightful digital screens which spark to life with characters delivering fun, animated, and inspirational messages. The Star Wars themed Play Space in the Children's ER encourages free play and socialization and allows kids to interact and make new friends. Visitors of all ages are surprised and excited to see the new Disney elements in our hospital, instantly making the hospital less scary and letting them know that we are going to help them get better.

In addition to seeing all of these classic settings and characters, children can engage with them through the Disney Team of Heroes app. Loaded with games, interactive tales, animated character encounters, augmented reality and more, the free app helps bring favorite characters to life.

For patients to enjoy full length Disney entertainment throughout the hospital as well as from their room, our IT team collaborated with Disney to bring complimentary access to the DisneyNOW app in the

hospital. The DisneyNOW app features the best of Disney TV content from Disney Channel, Disney Junior and Disney XD. This access on personal mobile devices can help ease loneliness during hospital stays.

Inpatients will be further delighted by receiving Themed Hospital Gowns and Care Packages. Featuring characters from Disney's beloved stories, these gowns are a comforting alternative to plain hospital wear - giving patients a sense of the familiar so their hospital stays are less intimidating. Patients may also be provided with a choice of Disney, Pixar, Marvel, Star Wars, or ESPN themed Care Packages filled with fun activities and keepsakes such as room decals, journals and playing cards, allowing children to personalize their hospital rooms.

Some of the magic experience can go with patients when they leave the hospital. Disney provides annual Toy Deliveries consisting of toys, books, and games. Throughout the year, staff members use these items to reward children for accomplishments such as getting their blood drawn, sitting still for a CT or being brave during an MRI.

No magic is complete without our staff who strive to provide exceptional care, compassion, comfort, and connection. Disney Institute provided customized training to hospital leaders and staff of all levels. Through this training, our hospital staff is able to personally bring the Disney magic experience to every child in need of a fun distraction. You will see our staff wearing themed staff badges, each representing the employee's favorite Disney character. These badges spark fun conversations and help create special moments.

"At AdventHealth for Children, we see first-hand the joy and reactions that come from patients and families who experience our Walt Disney Pavilion," said Dr. Rajan Wadhawan, senior executive officer of AdventHealth for Children. "Bringing that joy can be very important at what otherwise can be a stressful time in our patients' young lives."

This collaboration between AdventHealth for Children and Disney is having a huge impact as it eases the stress of a child's hospital stay. It's because of this focus that children and their families leave with positive experiences and new memories.

# The Vascular Center of the Future

Vascular disease claims more lives than any other cause of death in the US and can strike anyone at any time, regardless of age, gender or race. In addition, symptoms can appear and become worse before a person even notices them. Statistics predict a 20% increase in the incidence of vascular disease over the next 20 years. Unfortunately, vascular disease is also the costliest disease in America.

Creating a Vascular Center of Excellence was the chosen project for the Fund-a-Need initiative during the 2019 Golden Gala event. Over 2,000 Gala attendees helped raise more than \$915,000 towards creating a Vascular Center of Excellence that will help identify, prevent and treat vascular disease so people can live a whole, healthy life. Dr. Alan Wladis, physician leader of the Vascular Program, challenged Gala attendees by suggesting that "with a new Vascular Center of Excellence, we can become the epicenter of whole-person care by detecting, protecting and treating patients with these costly diseases." The Vascular Center of Excellence can identify those at risk of strokes, prevent negative outcomes such as limb amputations and save thousands of lives when emergency surgery is required. The Center will include a hybrid operating room for acute care vascular surgeries, DARE TO C.A.R.E. vascular disease screening program and a dedicated limb care program. Your compassionate generosity is making all of this possible!

Vice President of AdventHealth's Cardiovascular Institute Kimberly Bell shared, "Not only can we advance in prevention with our new Vascular Center of Excellence, we can care for more complex, emergency cases by creating a new vascular hybrid operating room where we can save 1,000 more lives a year from catastrophic life-threatening emergency procedures."



# First Ever Health Care Headquarters

As AdventHealth continues to grow and expand, making sure our patients receive the most streamlined and efficient health care experience possible can present challenges. In order to deliver innovative, whole-person care to our patients, AdventHealth, in partnership with GE Healthcare, opened the nation's largest health care command center, Mission Control, in August 2019.

AdventHealth's Mission Control is committed to making clinical operations across the health care system as effective as possible. Using artificial intelligence to inform and guide decision-making in areas such as emergency vehicle dispatch, smooth patient transfer between units and facilities, and prioritization of placement and treatment, the team significantly impacts patient interactions at AdventHealth.

From Mission Control's 12,000-square-foot, high-tech center on the Orlando campus, the team oversees activity at AdventHealth facilities in Orange, Seminole and Osceola counties. More than 50 employees from departments including nursing and emergency services to dispatch and transportation, oversee the control center 24 hours a day, seven days a week.

"AdventHealth is at the leading edge in deploying this technology to help provide the best, most efficient care possible for our patients," said Daryl Tol, president and CEO of AdventHealth's Central Florida Division. "While the command center is invisible to patients, our team of experts will be there around the clock to make sure patients receive the care they need, quickly and safely."

Mission Control will continue to evolve as the AdventHealth system evolves, setting new industry standards and simultaneously positioning AdventHealth as the leader in health care technology. AdventHealth is thrilled to provide an efficient health care experience to our patients.









# AdventHealth for Children's Second Annual Day of Giving

Having a child in the hospital with a serious illness, can turn a parent's world upside down. Families often struggle to make ends meet while they focus on their child's health and wellbeing. No parent should have to decide between staying by their child's bedside and working to pay the bills, but many face this reality and are forced to put their jobs on hold to be present for their sick child. AdventHealth for Children's Day of Giving was created in 2018 to help meet the urgent needs of families whose children are hospitalized.

In addition to the celebrities and iHeart Media personalities, a few children shared their personal experiences inspiring and reminding us all what this event truly means for families in our community. D.J., a thirteen-year-old bone cancer survivor and amputee said,

"It was very inspiring to help participate in this event and to know that sharing my experience can help others is so meaningful to me."


# 2019 Financial Impact



# From Heart Patient to Ninja Warrior



In his early 40s and in above average physical health, Vinny was training for his first appearance on the television show "American Ninja Warrior." The show features hundreds of competitors who attempt to complete strenuous obstacle courses of increasing difficulty. Just over a year into his training, Vinny started experiencing discomfort in his chest and abdominal area.

Vinny had just finished one of the more difficult courses when he started to feel pain that he compared to a pulled muscle. After sitting in his airconditioned car to cool down, he felt well enough to return to his course training. But the pain returned. He went about his day, thinking he had pulled a muscle.

Later, Vinny was sitting in traffic when the pain returned This time he wasn't doing any physical activity so he started to get concerned. Vinny made his way to the emergency room at AdventHealth Altamonte Springs where an electrocardiogram (EKG) revealed some alarming signs.

The nurses expressed surprise that he was awake and able to talk given his condition. Immediately, he was rushed to the cath lab to better assess his heart function. Thankfully, the team of specialists was able to find and remove a clot that was in the main heart valve. Vinny's condition is often called a widow-maker or a heart attack that occurs when there's 100% blockage in the left anterior descending artery.

Today, Vinny feels fortunate to be back in training for the "American Ninja Warrior" competition. Before his heart attack, Vinny's only mission was to train and compete in the popular series. Now, he has an

additional mission — to educate individuals and support cardiovascular patients like him by raising money through AdventHealth Foundation Central Florida.

Vinny's eye-opening experience is an example of why we all need to manage our health, no matter how old or how active we are. Could you be at risk for heart disease in the future? To get ahead of a potential diagnosis, be aware of the first symptoms of heart failure. Some may not seem like a big deal but as the disease progresses, symptoms will get worse. If you are experiencing or begin to experience any of the following, talk to your doctor about possible causes:

- Build-up of fluid that leads to swelling in your feet, ankles, legs or abdomen
- · Chronic coughing or wheezing
- · Confusion or impaired thinking
- Dizziness
- · Fast heart rate
- · Fatigue or weakness
- Nausea or loss of appetite
- · Shortness of breath

While heart disease is not always the cause of these symptoms, you and your doctor can work together to determine whether further testing and treatment are necessary.

Knowledge is power and knowing the symptoms to be aware of is very important. An annual wellness exam also plays a key role in the best preventive care for your health. Regular conversations with your doctor should include discussions of any recent changes in your medical history to prevent potential health risks down the road.

Our community proudly supports Vinny as he continues to heal and work toward returning to the "American Ninja Warrior" competition. His incredible story is a reminder of how important it is to be aware of your health at every age, no matter your lifestyle.
