

**ADVENTHEALTH FOUNDATION CENTRAL FLORIDA  
PLAY IT FORWARD DRAWING  
OFFICIAL RULES**

**NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

The AdventHealth Foundation Central Florida Play it Forward Drawing (“Drawing”) is conducted by Sunsystem Development Corporation doing business as AdventHealth Foundation Central Florida and AdventHealth Hendersonville Foundation under tax ID 59-2219301 (collectively, “Foundation”). The Foundation raises funds to benefit AdventHealth Orlando and AdventHealth Hendersonville.

**1. Eligibility:** The Drawing is open only to legal U.S. residents residing in the states of Florida and North Carolina (collectively, the “Eligibility Area”) who are at least eighteen (18) years old at the time of entry. The Drawing is subject to all applicable federal, state, and local laws and regulations. The Drawing is void outside of the Eligibility Area and where prohibited. **Online Entry**

During the Promotion Period, go to [www.AdventHealth.com/RaceForMentalHealth](http://www.AdventHealth.com/RaceForMentalHealth) and follow the instructions to be entered into the Drawing. **Limit:** One (1) online entry per person per calendar day (for purposes of this Drawing, a “calendar day” is defined as beginning at 12:00 AM ET and ending at 11:59 PM ET on any one (1) calendar date). Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different addresses, identities or registrations, or any other methods will void that entrant’s entries and that entrant may be disqualified. Use of any automated, robotic, repetitive, programmed or similar entry methods or agents to participate is prohibited and will result in disqualification.
